

**Saddlebrook Homeowners Association
Clubhouse Rental and Use Agreement
Owner Form**

This agreement is made this _____ day of _____, 20____ by and between the Saddlebrook Homeowners Association and _____ (Member's Name). Saddlebrook is the owner of the facility being requested in Star, Idaho; and Member is a homeowner in good standing of Saddlebrook Homeowners Association. Said Member desires to have the temporary, exclusive use of the Clubhouse on the date: _____, from the times of: _____ to _____.

Now, therefore, Saddlebrook does hereby license and authorize Member to have temporary and exclusive use of the Clubhouse, subject to Member's compliance with the following conditions:

1. A maintenance deposit and usage fee shall be paid to Saddlebrook Homeowners Association by the Member and shall accompany this agreement.
2. Member agrees to be present at all time while guests and other non-member people are present at the premises and facility. Under no circumstances will Member grant access to the premises and facility to a non-member without being present during the entire period that the non-member is present.
3. Member shall be solely responsible for cleaning the facility following Member's use, which responsibility shall include removal of all Member's property from the facility and premises and proper disposal of all trash, refuse, and debris.
4. Tables, chairs, counters, range and refrigerator must be washed and wiped clean. The facility must be vacuumed and other floor coverings must be left in a clean condition, which means mopping if necessary in the kitchen area. Please review the attached checklist to see how to clean the facility.
5. If Member cleans the facility to the satisfaction of Saddlebrook and/or its appointed inspection agent and if there is no physical damage to the facility, Saddlebrook shall refund the required deposit within ten days of date of Member's use of the facility. Member understands and accepts that Saddlebrook may keep and apply such portion of the deposit as may be necessary to adequately clean and repair the facility and premises.
6. Member accepts responsibility for all cleaning and repair costs including any costs that may exceed the required deposit.
7. No pets of any kind are permitted within the premises at any time.
8. No nails of any kind are to be used on the walls of the facility.
9. There is to be no cooking in the kitchen area, the oven and microwave are for reheating or keeping food warm.
10. All furnishings must be returned to their proper arrangement after use of the facility.
11. Member agrees to turn off all appliances and light fixtures and to lock the facility after use.
12. Member agrees to hold Saddlebrook harmless from all claims, liability or responsibility for injury or property damage, which may occur while this agreement is in effect.
13. Member accepts responsibility to assure that all guests and other users of the facility and premises follow all rules and requirements of Saddlebrook and its amenities.
